# **Minutes**

### Session Chaired by External Chair, Graham Stuart MP.

Graham Stuart welcomed attendees to the meeting and confirmed that with 16 attendees the APPG was quorate.

Graham Stuart asked for nominations for the role of Chair of the APPG. One nomination was received. Andrew Ranger nominated Chris Webb as Chair.

This was unanimously agreed.

Graham Stuart confirmed that there were 4 nominations for Vice Chair. Damian Hinds and Manuela Perteghella were present and standing to be Vice Chair. Caroline Voaden and Daniel Aldridge had also sent their intentions to stand in absentia.

As an MP for the Official Opposition, Damian Hinds was nominated by Charlie Dewhirst MP and was elected unanimously.

Manuella made some remarks about why she'd like to be Vice Chair.

The group voted by private ballot on the remaining spaces for Vice Chair.

Daniel Aldridge and Manuela Perteghella were elected as Vice Chairs.

Graham Stuart asked the group whether it approved the income and expenditure report for the APPG. This was approved with no further clarification or comments.

The Group moved approving its Annual Report.

Angus McDonald asked whether a letter would be written to the Scottish First Minister ahead of the Scottish Budget, similarly to the Chancellor, Rachel Reeves.

**Action:** The Group said it would consider whether it would be appropriate for the APPG to write to Welsh and Scottish Government ahead of their Budgets in January.

Graham Stuart asked the Group whether it approved its due diligence statement. This was approved with no further clarification or comments.

### As external Chair, Graham Stuart then left the meeting.

As elected Chair, Chris Webb MP announced that Stepanie Peacock, Tourism Minister, would be attending a meeting of the APPG on 13 January. He said that Visit Britain and Visit England would also be attending a meeting of the APPG in the next year to speak about their work and activity. Chris also detailed his ambition to take the APPG and its members around the country on a 'roadshow' to meet with businesses across the UK. Chris said he would be meeting with secretariat UKHospitality following this meeting to organise the future work plan for 2026.

APPG members discussed the future workplan for the next year.
